Re: Marshfield R-I School District FEMA Shelter

Dear Residents:

The Marshfield R-I School District is pleased to announce the completion of the Community Storm Safe Room, which is available for use during tornado and other weather-related events. The FEMA Shelter is located between Webster Elementary and Marshfield Junior High N. Locust Street and N. Elm Street.

The FEMA Shelter is owned and operated by the Marshfield R-I School District Marshfield, Missouri, and its first function is to provide protection for the students, staff, and faculty of Webster, Hubble, and Marshfield Junior High School during tornado and high wind events. The school FEMA shelter WILL NOT be open to the public during school operation hours. During non-school hours, the safe room will be available to the public during tornado and other severe weather events. The Safe Room will be available to anyone in the Marshfield area that does not have a basement or other safe room. It will open to anyone needing Safe Room; there is no fee to use the Safe Room. However, the Shelter does have a maximum capacity of 1,200 persons; household animals, excluding Aid Animals, are not allowed in the Safe Room. If you have special needs that we should be aware of, please complete the special needs form located on the district website.

Storm Sirens shall be activated and the Safe Room will be opened:

1. The National Weather Service issues a TORNADO WARNING, OR a trained spotter reports a tornado:
  - In Webster County, Greene County, Dallas County, or Christian County
  - **AND the tornado path includes the Marshfield area**

**Or**

1. The National Weather Service reports a storm system producing wind speeds of 75 MPH or greater, **AND the storm path includes the Marshfield area.**

1. The sirens sound a steady tone for three minutes. The sounding of the sirens means **"Move Inside Immediately and Seek Cover!"**

1. Outdoor Warning Sirens may be sounded multiple times during the warning.

1. **Marshfield does not sound an all-clear siren.** Please listen to your NOAA Weather Radio or other info sources.
